⁴⁾ No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents - or one of these - were born Danish or have subsequently obtained Danish nationality.

⁵⁾ Where several documents are issued at the same time, a total fee of DKK 195 (BGN 52) shall be charged.

- ⁶⁾ Provided the request for VAT refund comprises several separate purchases, a fee of DKK 195 (BGN 52) shall be charged per statement.
- ⁷⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 3,905 (BGN 1025) shall be charged for the first passport and DKK 960 (BGN 255) for subsequent passports.
- ⁸⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 5,580 (BGN 1470) shall be charged for the first passport and DKK 960 (BGN 255) for subsequent passports.
