4) Where several documents are issued together to the citizen, a total fee of DKK 285 (BGN 75) shall be charged.

5) Provided the request for VAT refund comprises several separate purchases, a fee of DKK 225 (BGN 60) shall be charged per statement.

6) Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 2,640 (BGN 695) shall be charged for the first passport, and DKK 1.130 (BGN 296) or DKK 1.782 (BGN 470) for subsequent passports.

7) Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 3.770 (BGN 990) shall be charged for the first passport, and DKK 1.130 (BGN 296) or DKK 1.782 (BGN 470) for subsequent passports.
